



The results have been corrected for recovery.

"The analyzed sample corresponds to: Argentine Groundnut Kernels, Runner".

We conclude that the goods were stuffed in sound condition and according with FOSFA Contract Nr. 39 are warranted of good merchantable quality of their description. Goods are free from visible mould presence infestation and obvious presence of rodents. No responsibility can be accepted for the possible consequences of further development of Aflatoxin producing moulds dependent upon conditions of storage and/or transportation nor for differences arising from varying methods applied.


